Terms and Conditions:

1. Full payment of charges for the entire length of the rental is due upon the return of the rented items. Credit card pre-authorization or other approved deposit is required upon signed agreement of customer. Customer is responsible for equipment at all times and agrees to compensate MEADIA solutions (40903 Yukon Inc.) for full replacement value in the event of breakage, theft or any other caused damage resulting in total loss of the equipment.
2. All equipment, accessories and software rented by the customer is and shall remain the property of MEADIA solutions. Customer shall not remove, alter or deface any stencil, plate, label or other indication of MEADIA solutions ownership. Customer shall have no rights or property interest in the equipment other than as set forth in this agreement.
3. The equipment can be picked up after 4:00 pm the previous day and returned before 12:00 pm the following day without additional charge. The customer may extend the rental period of the equipment only after contacting MEADIA solutions and obtaining verbal or email consent. Any equipment held and then returned after the set upon agreed return date will be charged at twice the rate indicated herein for each installment period or portion thereof if prior verbal consent had not been granted and MEADIA solutions had previously committed such equipment to another customer based on the original agreed upon return date as stated herein.
4. This agreement is subject to business credit references if requested by MEADIA solutions.
5. The equipment shall remain with the below signed customer as indicated on this agreement throughout the rental period. MEADIA solutions shall have the right to inspect the equipment at the indicated location at any time, with or without cause, during normal business hours and with reasonable advance notice to the Customer.
6. The location, use and storage of equipment shall be such to provide at all times reasonable safeguards against damage, loss or theft. Customer shall not engage in any activity, or permit the equipment to be used in connection with any activity legal or illegal, which could result in confiscation, attachment or removal of, or the placing of any lien upon the equipment.
7. Customer promises to return the equipment in the same condition as upon delivery, ordinary wear and tear accepted. Customer assumes full responsibility for loss, damage or injuries resulting from the use of the equipment and shall be liable to MEADIA solutions for the loss or any damage to the equipment or accessories to the full replacement value thereof.
8. Customer shall promptly notify MEADIA solutions of any malfunction of the equipment. MEADIA solutions shall bear the cost of servicing and repairs except for the repairs made necessary by the Customer's fault or negligence in which case the Customer shall pay for such service at the current MEADIA solutions posted service repair rate.
9. Any amount due and unpaid under this agreement shall bear interest at the rate of 1.5% per month (18% APR).
10. If any provision under this Agreement shall be held invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions shall not in any way be impaired. Any present or future claims arising out of or relating to this agreement or the breach thereof by either party shall be decided by arbitration in accordance with Yukon Law. The decision of the arbitration shall be final, and the judgment thereon may be entered in any court having jurisdiction thereof.
